THIS NOTICE IS GIVEN AT THE DIRECTION OF THE MAYOR PURSUANT TO CHAPTER 21, CODE OF IOWA AND THE LOCAL RULES OF SAID GOVERNMENTAL BODY. POSTED OCTOBER 14, 2022.

Mayor Brenno called the Cresco City Council meeting to order on October 3, 2022, at 5:30 pm. Council Members Kriener, McConnell, Fortune, Bouska, and Carman were present. No council members were absent.

Carman made the motion to approve the consent agenda which included approval of the: agenda; claims; minutes from September 19, 2022. Bouska seconded and it passed all ayes.

Public Works Director Widell reported: (a) another watermain leak on 4th Street West on a short stub that is in very poor condition. Mehmert's is working on a quote to replace the 275 feet; (b) Water Department is flushing hydrants this week so there could be some rusty water around town; (c) today was the first day for the Fall yard waste pick up with four more dates ending November 14th.

Police Chief Ruroden presented the September call report and noted there have been raccoons with distemper. Officer trainings will be done in October. They are anxious for Officer Welper's graduation from the Academy next month.

City Clerk Elton reported: (a) the CIP should be ready this week to email to Council for ranking projects and then a worksession may be needed to discuss. Bouska reported October 13th a free all-day session in Calmar for electric vehicles aimed at business owners but also addressing individual concerns as well. October 17th at 5 pm there will be dedication of the City's new EV Charging Station in Fareway's parking lot before the regular Council meeting.

Brenno reported that he, Rich and Amy met with Bud Johnson at the Pickleball Courts to thank him for his \$20,000 grant for the project. Everyone is excited for how the project turned out and all the generous donations received.

Bouska reported that she and Niki both attended the Iowa League of Cities in Waterloo.

Mayor Brenno asked for comments from the audience. Deb Schmidt voiced concerns regarding the cost of recycling. Dodd Franklin addressed the problem when there is excess recycling that used to be dropped off at the recycling center. Mayor Brenno explained that the City and County are exploring options for recycling.

Hotel/Motel Tax of \$6,220.07 was received this quarter with three applications requesting \$4,500. McConnell made the motion to approve the recommendation of the Tourism Committee and award Hotel/Motel Tax Grant to: Cresco Chamber of Commerce \$1,000 for the Santa Parade; Cresco Theatre \$500 for Looney Lutheran's Christmas Show; Cresco Wildlife Club \$3,000 for new flooring. Kriener seconded and it passed all ayes.

McConnell made the motion to approve the resolution Establishing Electric Vehicle Charging Station Fees. Bouska seconded and it passed all ayes.

Carman made the motion to authorize the City Clerk to sign an Offer of Employment to Amber Yanes for the Billing Clerk Position. Bouska seconded and it passed all ayes.

Discussion was held regarding the Hawkeye Recycling proposal of a ten-year contract for \$4,000 per month from the City of Cresco and also from Howard County with a rate increase of 3% to 10% annually. Hawkeye Recycling would then open the drop-off site like it had been prior to closing the gate. If the proposal is rejected, Hawkeye Recycling will require payment for recycling to be dropped off at the Recycling Center. Curb-side pickup of recycling for residential and commercial accounts will continue regardless of the proposal decision per the agreement between the City and Hawkeye Sanitation. McConnell made the

motion to reject the proposal from Hawkeye Recycling. Bouska seconded and it passed all ayes.

Bouska made the motion to approve the Application for Authorized Collector for Dumpster Services of Non-Recyclable Waste Collection and Recyclable Waste for Commercial and Industrial Customers. Carman seconded and it passed all ayes.

Bouska made the motion to approve the vacation carryover request for Michelle Elton. Carman seconded and it passed all ayes.

Carman moved to adjourn at 6:08 pm. McConnell seconded and it passed all ayes. The next regular Cresco City Council meeting will be October 17, 2022, at 5:30 pm at Cresco City Hall.

Mayor Brenno called the Cresco City Council special meeting to order on October 12, 2022, at 5:15 pm. Council Members Kriener, McConnell, Fortune, Bouska, and Carman were present. No council members were absent.

Mayor Brenno asked for comments from the audience and there were none.

Paul Gamez introduced himself as the Attorney representing Hawkeye Sanitation and Ross, Julian and Lucas Merritt. He pointed out that the City of Cresco and Hawkeye Sanitation had a long relationship working together for more than 30 years. Attorney Gamez pointed out certain sections of the current agreement between the City of Cresco and Hawkeye Sanitation that he believes supports the notion that the agreement gives Hawkeye Sanitation exclusive rights to be the collector of all garbage and recycling in the City limits including heavy commercial waste. Attorney Gamez requested time to compile and submit financial information justifying the rate increases for the heavy commercial accounts. He also requested the Council to consider implementing a Dispute Resolution Mechanism with the assurance from Hawkeye Sanitation to participate. He requested that Council consider delaying approval of Permits for Authorized Collectors for Dumpster Services.

Discussion was held between the City Council, Hawkeye Sanitation, the City's Attorney John Anderson, and Hawkeye Sanitation Attorney Paul Gamez.

Bouska made a motion at 6:42 pm to go into closed session pursuant to Iowa Code 21.5(1)(c) to discuss strategy with counsel regarding potential litigation. McConnell seconded and it passed all ayes.

Fortune made a motion at 7:48 pm to go into open session. Bouska seconded and it passed all ayes. No formal action was taken during the closed session.

City Clerk Elton reported the selenium results for the sludge have been received so we are ready to start hauling the sludge out of the large storage tank. Bouska made a motion at 7:51 pm to go into closed session pursuant to Iowa Code 21.5(1)(c) to discuss strategy with counsel regarding potential litigation. Fortune seconded and it passed all ayes.

McConnell made a motion at 8:05 pm to go into open session. Kriener seconded and it passed all ayes. No formal action was taken during the closed session.

McConnell made a motion to table further action on the review and approval of permit applications for authorized collectors for dumpster services until the November 21, 2022 Council meeting. Bouska seconded and it passed all ayes.

Council discussed the CIP project listing and agreed to rank the projects individually. The City Clerk will compile the rankings and a worksession will be scheduled to discuss it further.

Carman moved to adjourn at 8:10 pm. Kriener seconded and it passed all ayes. The next regular Cresco City Council meeting will be October 17, 2022, at 5:30 pm at Cresco City Hall.




Street Closing Parade Permit (Rev. 8/2020)

Dear Mayor and Members of the City Council:

The purpose of this Engagement Agreement ("Agreement") is to disclose and memorialize the terms and conditions under which services will be rendered by Ahlers & Cooney, P.C. in representing the City of Cresco (the "City") in connection with the above-referenced special assessment project.

I understand the City intends to reconstruct crosswalks, sidewalks and pedestrian ramps in the downtown area and assess certain costs associated with the project to the properties that are specially benefitted by the improvements.

SCOPE OF ENGAGEMENT

We will perform the following services:

- 1. Review the engineer's preliminary plat and schedule of assessments for compliance with Iowa law;
- 2. Prepare letters of instructions throughout the special assessment process;
- 3. Answer questions and advise City staff and Council throughout the special assessment process;

- 4. Prepare proceedings and documents for initiation of the special assessment project, including:
 - a. Notice of Meeting and partial agenda covering matters below under the open meetings law.
 - b. Proceedings to be acted upon by the City Council in order to commence formal action, including the following:
 - i. Preliminary resolution for construction of street improvements,
 - ii. Resolution fixing value of lots,
 - Resolution adopting preliminary plat and schedule and estimate of costs.
 - iv. Resolution of necessity, and
 - v. Notice of hearing on resolution of necessity
 - c. Certificates to evidence:
 - i. Publication of the Notice to Property Owners.
 - ii. Mailing of the Notice to Property Owners.
- 5. Prepare proceedings for the hearing on the Resolution of Necessity, including the public meeting notice and separate instructions for its use;
- 6. - 8. Prepare Certificate with respect to agricultural deferment (if applicable);
- 9. Prepare proceedings to cover the hearing on the plans, specifications and form of contract for the public improvements;
- 10. Review the Engineer's proposed final assessment plat and schedule for compliance with Iowa law;

- 11. Prepare proceedings for the final phase of the special assessment project, including:
 - a. Resolution accepting work;
 - b. Resolution ordering preparation of final plat and schedule of assessments;
 - c. Resolution adopting and levying final schedule of assessments;
 - d. Certificate of levy of assessments to be filed by the Clerk with the County Treasurer;
 - e. Notice of filing final Plat and Schedule of Assessments to be published and mailed to each property owner;
 - f. Certificate regarding publication of notice;
 - g. Certificate regarding mailing of notice;
 - h. Special Assessment Collection Statement; and
 - i. Mailing instructions.

Our duties <u>under this particular engagement</u> are limited to those expressly set forth above. Absent a separate engagement agreement regarding one or more of the following services, our duties under this Agreement do not include:

- 1. Defending any legal challenges to the special assessment:
- 2. Reviewing, revising, or negotiating the City's contract with its architect or engineer;
- 3. Reviewing and revising the terms and conditions of the City's contract for construction of the public improvements; and
- 4. Any bond (finance) related services.

ATTORNEY-CLIENT RELATIONSHIP

Upon execution of this Agreement, the City will be our client and an attorney-client relationship will exist between us for the above referenced special assessment project. Our services are limited to those contracted for in this letter and the City's execution of this Agreement will constitute an acknowledgement of those limitations. Our representation of the City and the attorney-client relationship established by this Agreement will be concluded upon payment of our final invoice.

FEES

We will charge a flat fee for services rendered under this Agreement. Our fee should not exceed \$7,540. If we determine that an adjustment of our fee is necessary, we will advise you. Such adjustment might be necessary in the event that (a) either the Project Engineer or City staff fails to comply with the requirements of Iowa Code Chapter 384; (b) there is insufficient cooperation and coordination from the project engineer; and / or (c) unusual or unforeseen circumstances arise which require a significant increase in the services rendered, such as personal attendance at meetings, significant travel, or unexpected revision of the above referenced documents. Typically, personal attendance at Council meetings is not necessary in order to provide the services outlined above. We will, however, attend Council meetings in the event that circumstances require.

In addition to the flat fee quoted above, we will bill the City for all expenses incurred on its behalf, such as travel cost reimbursement, photocopying, deliveries and other related expenses. We estimate that such charges will not exceed \$500. We will contact you prior to incurring expenses that exceed that amount.

Our statement for services and expenses will be sent after publication of the second notice of filing of the Final Plat and Schedule of Assessments. Payment is due and payable within thirty (30) days of receipt of the invoice.

If, for any reason, the City terminates the engagement governed by this Agreement before the special assessment is levied or, if the project is cancelled, we will bill the City for the services rendered as of the date of termination based on the hourly rates of those who provided services. The fees charged by the Firm for this representation will be based on the current hourly rate of the person performing the service at the time services are performed. We will also bill you for all expenses we have incurred as outlined above. My hourly rate for 2022 is \$260. Services performed on your behalf by legal assistants will be billed at \$125 per hour. The Firm's billing rates are reviewed, and sometimes revised, annually in January. Accordingly, these rates are subject to change in January of each year.

RECORDS

At the City's request, any documents furnished by the City will be returned promptly upon receipt of payment for outstanding fees and client charges. Our own files, including lawyer work product, pertaining to the above referenced project will be retained by us. For various reasons, including the minimization of unnecessary storage expenses, we reserve the right to dispose of any documents or other material retained by us after the termination of this engagement.

APPROVAL

Please carefully review the terms and conditions of this Agreement. If this Agreement accurately reflects the terms of this particular engagement, please obtain approval by your governing body, and execute, date and return to me the enclosed copy of this Agreement. Please retain the original for your file.

If you have questions regarding any aspect of the above or our representation, please do not hesitate to contact me. We appreciate the opportunity to represent the City of Cresco and we look forward to working with you on this matter.
