2. The commission talked about our plans to construct hangers and the direction we want to go. The commission asked Clair to contact Rob Garber from engineering firm Kirkham-Micheal to find out what his firm has to offer in the way of future hanger construction. Rob was with us this evening and he is happy to help us in the process of getting state grant funding to build new hangers. He will provide information about state funding and what portion the airport/city would be responsible for.
3. We talked about what type of hangers we would like to see built. Romaine suggested 44' X 36' wood post frame hangers with 4/12 pitched roof trusses, clear span inside, with steel side and roof panels. He would like them to have 42' Bi-fold doors. The commission seemed agreeable to this size of hangers. We would also like to see at a minimum of concrete inside for planes to sit on while in the hanger. Romaine agreed to take these specifications to local contractor to get bids and bring that back to us for further discussion at our next meeting.
