2. Jerry reported Midwest Custom Ag Aviation is progressing along to have the permanent loading pad constructed in hopes of using it for this year's operations. Mehmert is going to do the site prep as well for Midwest & so may use the time frame to do the runway project if the time frame worked out for the runway project. With this sort of construction, weather & conditions is a major factor.
3. Concerning hangers... Clair reported that since Kevin wasn't around during the winter that he and Rich didn't look into it any further other than what Rich had received from Ken Panos as to construction estimate for one hanger. Josh Dank, from CGA Engineering, had suggested costs for larger hangers & that grant applications can be made with local share costs covered by the private owner/user, with lease agreement.
4. Clair reported that with the VASI lighting being decommissioned and removed, any electrical work will follow after completing the runway project. He does not foresee any extra financial costs other than normal repairs & seasonal mowing. He will close runway with FAA, & NOTEMS will be posted to inform aviators during the time of reconstruction.
