Cresco does not hold a formal 4th of July display, and we are happy to hold this display not only for ourselves but for the surrounding community to celebrate independence.

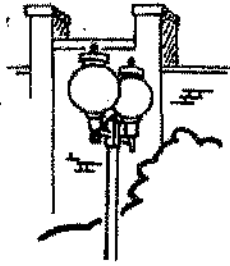
In addition, we apply for and provide the following each year:
