Council Meeting Notes - November 21, 2022

<u>Downtown Crosswalk Project</u> – at the last meeting Council could not agree on the percentage to assess property owners for recently replaced sidewalks. The resolution was approved to defer the decision to this meeting. The Council needs to discuss and come to an agreement for how to proceed with the project. Reminder that you did already approve the Professional Services Agreement for WHKS to go to the next step of drafting the specs and preparing the docs to go out for bids.

- There was a motion that failed to reduce the assessment to 50% for any property owner that had replaced their sidewalk in the past nine years.
- 2) There was a motion that failed to charge 90% assessment for the sidewalk replacement to all property owners regardless of any recent replacements.
- 3) There has been a suggestion to reduce the assessment a pro-rated percentage based on how recent the replacement occurred for replacements occurring in the past five years. (Five years was the maximum number of years the Engineer had seen used by other communities.)

Sidewalk replaced in 2021: assess 50% of sidewalk costs (as opposed to 90%)

Sidewalk replaced in 2020: assess 60% of sidewalk costs Sidewalk replaced in 2019: assess 70% of sidewalk costs

Sidewalk replaced in 2018: assess 80% of sidewalk costs

Sidewalk replaced in 2017 or earlier: assess 90% (i.e., normal) of sidewalk costs Written proof that the work was done in the year that they're claiming is required

The Council must come to an agreement if this project is going to move forward. The Resolution of Necessity must be approved by 75% of the full council so this means we need 4 yes votes to be approved. If the Council cannot come to a compromise and get the 4 votes needed, then the project must be abandoned. The Council may vote to defer for later consideration again, but remember this could push back the next step and cause the bid-letting to be done even later in the spring.

<u>Pickleball</u> – This project is complete and so now the Council should accept it. The 5% retainage will then be paid out 30 days after acceptance. Heartland Asphalt came in under budget due to a change order and a reduction in actual quantities used. The overall total was \$130,351 in expenses. We received the Bud Johnson grant of \$20,000 and donations of \$90,150. The City transferred \$30,000 from Local Option Sales Tax ("LOST") to be put towards the project. Therefore, we have **\$9,799 cash remaining** to be used for lighting upgrades, a storage shed, and bleachers or benches and maintenance.

January Council Meetings – The first Monday in January is January 2nd which is a holiday. We will need to reschedule that meeting. The third Monday January 16th is a legal holiday for Martin Luther King Jr Day (which the City does not observe so really would not affect us). In looking at the calendar at the end of December and all the holidays, it will be difficult to prepare for a meeting the first week of January. Also, there will be a long gap from Jan 16th to Feb 6th. Since there are 5 Mondays in January, I am wondering if we could schedule the meetings for the 2nd and 4th Mondays so January 9th and January 23rd. This way the 3-week gap will be at the end of December and beginning of January when we have all the holidays and year end work that needs to be done. We may need these dates confirmed for project dates for the attorneys and Engineers to schedule around.

Mayor Brenno called the Cresco City Council meeting to order on November 7, 2022, at 5:30 pm. Council Members Kriener, McConnell, Fortune, and Carman were present. Council Member Bouska was absent.

Carman made the motion to approve the consent agenda which included approval of the: agenda; claims; minutes from October 17th Council meeting and special meeting and November 1st worksession. Kriener seconded and it passed all ayes.

Public Works Director Widell reported: (a) sludge results have been received after bulking the big storage tank with lime and will begin land-applying soon; (b) Verizon is ready to proceed with erecting a mono-pole cell tower near our small water tower in 2023; (c) the last yardwaste pick up will be November 14th.

Police Chief Ruroden submitted the October police report. Officer Blake Welper graduated from the academy with the Top Athlete Award. The new charger is now in service and the old K-9 car will be sold at Burke Auction.

City Clerk Elton reported they are working on the budget, projects, and health insurance renewal.

Mayor Brenno asked for comments from the audience and there were none.

Daren Sikkink and Scott Huneke from WHKS presented the proposed Downtown Crosswalk Reconstruction Special Assessment Project. They described the proposed project and calendar. Special assessment projects have several required steps to follow and the attorney has drafted the proposed resolutions. The proposed project is located on North Elm Street from 1st Ave to 3rd Ave. The project consists of replacing the existing colored crosswalks, installing ADA compliant pedestrian ramps, and replacing all existing sidewalks, valve boxes, curbs, and gutters. Some water shut-offs and storm sewer intakes may be replaced. The Engineer's opinion of probable construction costs is \$797,980 for the total project of which \$251,770 is assessable to 48 property owners leaving the City's share to be 68%. The average assessment for the 48 properties is \$4,900 for 50% of the curb and gutter and 90% of the sidewalk replacement. It is anticipated to go out for bids in April for work to be completed in 2023.

Mayor Brenno opened the Public Hearing on the proposed Resolution of Necessity for the Downtown Crosswalk Reconstruction Project. Two written objections were read aloud from Jim & Connie Zahasky and from Dr. Jeffrey Leeper. Barb Prochaska, Phil Henry, and Jeff Leeper questioned why their newer sidewalks need replacing. Sikkink explained that some communities have made exceptions for properties that had recently made improvements. He said the Council could pick a number of years to go back and assess a smaller percentage to those property owners. He said typically they only go back five years and would reduce the sidewalk assessment to 50%. Alex Buls asked if only the curb, bad spots, and colored portions in the sidewalks could just be replaced. WHKS explained that in order for all of the sidewalks to be tied together and ADA compliant they were recommending replacing all sidewalks. Mark Brincks asked about water shut-offs and valve boxes and WHKS verified they would be checked and replaced if necessary. Roy Gorter encouraged the Council to move forward with the project since it has been discussed for several years and needs to be done. The public hearing was closed.

Carman made the motion to approve the resolution with respect to the adoption of the resolution of necessity proposed for the Downtown Crosswalk Reconstruction with an amendment to reduce the sidewalk assessment to 50% for properties that had replaced their sidewalks in the past nine years. There was no second to the motion so it failed.

McConnell made the motion and Fortune seconded for adoption of the resolution of necessity proposed for the Downtown Crosswalk Reconstruction as originally presented. Fortune, Kriener, and McConnell voted aye. Carman voted nay. Because this resolution requires 75% of the full council (4 votes) to pass, this motion failed.

A full council is expected to be present at the next meeting, so there would be five voting members. Kriener made the motion to approve the resolution with respect to the adoption of the resolution of necessity proposed for the Downtown Crosswalk Reconstruction to defer for later consideration to a Council meeting to be held on November 21, 2022 at 5:30 pm at City Hall, with jurisdiction retained for further consideration and action at the adjourned meeting. Fortune seconded and it passed all ayes.

The resolution directing preparation of detailed plans and specifications, form of contract and notice to bidders on the Downtown Crosswalk Reconstruction was tabled until November 21, 2022.

Carman made the motion to approve the resolution authorizing the Mayor to enter into a Professional Services Agreement – amendment no. 1 with WHKS & Co. for the Downtown Crosswalk Reconstruction Project. Kriener seconded and it passed all ayes.

A request was received for a credit on sewer charges from Anna Schmauss for Legacy Gym due to a broken boiler that leaked water into the basement. There were no floor drains and the water was pumped out into the alley. Kriener made the motion to approve a sewer adjustment of \$126.50 for water not entering the sanitary sewer system. Fortune seconded and it passed all ayes.

McConnell made the motion to approve the resolution accepting work for the Airport Runway Drainage Improvements Project. Kriener seconded and it passed all ayes.

McConnell made the motion to approve the resolution authorizing the Mayor to enter into an Engagement Agreement with Ahlers & Cooney, P.C. for contract review. Fortune seconded and it passed all ayes.

Daren Sikkink from WHKS presented the projected additional costs of splitting the 7th Street West Reconstruction Special Assessment Project into two smaller projects. The additional estimated cost was projected to be about \$265,000 in five years. Council had discussed this at the November 1st worksession and unanimously agreed it should be done at one time as one big project.

Carman made the motion to approve the resolution authorizing the Mayor to enter into an Engagement Agreement with Ahlers & Cooney, P.C. regarding the 7th Street West Reconstruction Special Assessment Project. McConnell seconded and it passed all ayes.

Carman made the motion to approve the preliminary resolution for the construction of street, water, sanitary sewer, storm sewer and other public improvements in the City of Cresco, State of Iowa. McConnell seconded and it passed all ayes.

Carman made the motion to approve the resolution fixing values of lots for the 7th Street West Reconstruction Special Assessment Project. McConnell seconded and it passed all ayes.

Kriener made the motion to approve the resolution adopting preliminary plat and schedule, estimate of cost and proposed plans and specifications for the construction of the 7th Street West Reconstruction. Fortune seconded and it passed all ayes.

Fortune made the motion to approve the resolution of necessity (proposed) for the 7th Street West Reconstruction Special Assessment Project and set the public hearing for December 5, 2022 at 5:30 pm. Kriener seconded and it passed all ayes.

Carman made the motion to approve the resolution authorizing the City Clerk to sign the health insurance contract with Wellmark Blue Cross/Blue Shield. Kriener seconded and it passed all ayes.

McConnell made the motion to approve the resolution authorizing the City Clerk to enter into a Third-Party Administration Service Agreement with Employee Benefit Systems "EBS". Fortune seconded and it passed all ayes.

Carman moved to adjourn at 6:50 pm. McConnell seconded and it passed all ayes. The next regular Cresco City Council meeting will be November 21, 2022, at 5:30 pm at Cresco City Hall.

	The Amended and Restated (2016) Cresco Urban Revitalization Plan allows property tax exemptions as follows:
	Residential: All qualified real estate assessed as residential property is eligible to receive a one hundred percent (100%) exemption from taxation on the first seventy-five thousand dollars (\$75,000) of actual value added by the eligible improvements. The exemption is for a period of five (5) years. Actual assessed value must increase at least 10% due to the improvements.
	Residential with Three or More Separate Dwelling Units: All qualified real estate assessed as residential property under Iowa Code Section 441.21(14)(a)(6) on or after January 1, 2022, having three or more separate dwelling units, is eligible to receive a fifty percent (50%) exemption from taxation on the actual value added by the improvements. The exemption is for a period of ten (10) years. Actual assessed value must increase at least 10% due to the improvements.
X	Commercial: All qualified real estate assessed as commercial property is eligible to receive a one hundred percent (100%) exemption on the actual value added by the eligible improvements. The exemption is for a period of three (3) years. Actual assessed value must increase at least 10% due to the improvements.
	Multi-residential (Prior to January 1, 2022): All qualified real estate assessed prior to January 1, 2022 as commercial property or multi-residential property, if the commercial or multi-residential property consists of three or more separate living quarters with at least seventy-five percent of the space used for residential purposes, is eligible to receive a one hundred percent (100%) exemption from taxation on the actual value added by the eligible improvements constructed prior to January 1, 2022. The exemption is for a period of three (3) years. Actual assessed value must increase at least 10% due to the improvements.
	In order to be eligible, the property must have been located in the Cresco Urban Revitalization Area when the improvements were made. The Area includes:
	All property located within the Cresco corporate limits as of March 21, 2016. Any property annexed into the City in the future shall automatically be included in the Area as of the effective date of the annexation.

ORDINANCE NO. 501

TRAFFIC AND VEHICLES

AN ORDINANCE AMENDING THE CODE OF ORDINANCES, CITY OF CRESCO BY ADDING NEW CHAPTER 81 PERTAINING TO RECREATIONAL VEHICLES

BE IT ENACTED BY THE COUNCIL OF THE CITY OF CRESCO AS FOLLOWS:

SECTION 1. NEW CHAPTER. The Code of Ordinances of Cresco, Iowa is hereby amended by adding a new Chapter 81, Recreational Vehicles, as follows:

CHAPTER 81

RECREATIONAL VEHICLES

81.01 Purpose 81.02 Definitions 81.03 Permitted Uses 81.04 Tents

81.05 Exception for Extended Habitation 81.06 Violations a Municipal Infraction

- 81.01 PURPOSE. The purpose of this chapter is to regulate the use of recreational vehicles in the City of Cresco for the protection of the public convenience, health, safety, and welfare.
- 81.02 **DEFINITIONS.** For use in this chapter the following terms are defined:
- 1. "Recreational vehicle" shall mean a vehicle or structure so designed and constructed in such a manner as will permit occupancy thereof as sleeping quarters for one or more persons, or the conduct of any business or profession, occupation, or trade.
- 2. A recreational vehicle may be towed or self-propelled on its own chassis or attached to the chassis of another vehicle and designed or used for occupancy, recreational, or sporting purposes.
- 3. Recreational vehicles shall include, but shall not be limited to, travel trailers, pick-up campers, camping trailers, mobile homes, motor coach homes, converted trucks and buses, and boats and boat trailers.

81.03 PERMITTED USES.

- 1. Recreational vehicles shall be used for vacation or recreation purposes and not used as a place of human habitation for more than seven (7) days in any three (3) month period within the City, unless in a designated public campground(s) where other rules and regulations may govern the use these properties.
- 2. Recreational vehicles for purposes of permanent habitation shall not be allowed anywhere in the City.
- 3. The parking of a mobile home shall not be allowed in any district, except in an approved mobile home park.
- 4. Recreational vehicles shall not be allowed to be parked upon the boulevard or front yard for more than forty-eight (48) consecutive hours.

5. Recreational vehicles, small utility or boat trailers, with or without a boat, may be stored in a rear yard, provided that no living quarters shall be maintained or any business conducted in connection therewith while such trailer is parked or stored.

81.04 TENTS.

- 1. Recreational overnight tent camping, not for a fee or other payment, in privately owned yards, lots, or other tracts of land within the City of Cresco is limited to a maximum of two tents.
- 2. Tents shall be used for vacation or recreational purposes and not used as a place of human habitation for more than seven (7) days in any three (3) month period.
 - Tent camping for purposes of permanent human habitation shall not be allowed.
- **81.05 EXCEPTION FOR EXTENDED HABITATION.** The City Council by resolution may extend the seven (7) days in any three (3) month period human habitation limits imposed on recreational vehicles and tents as enumerated in sections 81.03 and 81.04 of this code of ordinances for extenuating circumstances. Extenuating circumstances may be, but not limited to, the constructing of a new home, or the repair and rehabilitation of an existing dwelling in the City; whereby the person or persons of a dwelling unit in the City cannot inhabit it for a period of time until construction, repairs or rehabilitation is completed.
- 81.06 VIOLATIONS A MUNICIPAL INFRACTION. A violation of the provisions of this chapter may also be considered a municipal infraction, as provided in *Code of Iowa* Section 364.22. If a municipal infraction citation is served, the procedures for enforcement of the civil offense shall be governed by Chapter 4 of this Code of Ordinances.
- SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- **SECTION 3. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.
- **SECTION 4. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.

SECTION 1. The Code of Ordinances of Cresco, Iowa is hereby amended by adding a new Chapter 81, Recreational Vehicles, as summarized below:

Recreational vehicles and tents shall be used for vacation or recreation purposes and not used as a place of human habitation for more than seven (7) days in any three (3) month period.

Permanent habitation in recreational vehicles and tents is prohibited.

Mobile homes are only allowed in an approved mobile home park.

Recreational vehicles shall not be parked upon the boulevard or front yard for more than forty-eight (48) consecutive hours.

Recreational vehicles, and small utility or boat trailers may be stored in a rear yard, provided that no living quarters are maintained.

Violations may be considered a municipal infraction. The procedures for enforcement of the civil offense shall be governed by Chapter 4 of this Code of Ordinances.

SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.
