Mayor Bohle called the Cresco City Council meeting to order on December 16, 2019, at 7:00 pm at City Hall. Council Members Brenno, Fortune, and Bouska were present. Council Members McCarville and Carman were absent.

Bouska made the motion to approve the consent agenda which included approval of the: agenda; claims; minutes of the December 2, 2019 meeting; Class C Liquor License (LC) (commercial) for Big Daddy Hideaway Corp d/b/a Hideaway Lounge with Sunday sales; Class C Liquor License (LC) (commercial) for Howard County Agricultural Society d/b/a Mighty Howard County Fair—Howard County Expo with outdoor service and Sunday sales; pay request #3 for \$33,375.61 for Skyline Construction for Vernon Road Watermain Improvements Project; Excavator Licenses for: James Henry d/b/a Henry's Backhoe Service, Mracek Plumbing, Heating & Electric LLC, Mehmert Tiling, Inc, Skyline Construction Inc, MB Inc; Tree Surgeon Licenses for: Kittelson Consulting Aborist LLC, Total Tree Care LLC, Tim Walton d/b/a Tim Walton Tree Service, Complete Tree Service LLC, Wilson Custom Tree Trimmers LLC. Starting January 6th, the Library will close one hour earlier Monday – Thursday at 7 pm. They are updating the Library Policy Manual.

ORDINANCE NO. 481

TRAFFIC AND VEHICLES

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF CRESCO, IOWA BY AMENDING PROVISIONS PERTAINING TO GOLF CARTS AND UTILITY TRAIL VEHICLES (UTVs)

BE IT ENACTED BY THE COUNCIL OF THE CITY OF CRESCO AS FOLLOWS:

SECTION 1. SECTION MODIFIED. Chapter 74.05 of the Code of Ordinances of the City of Cresco, Iowa, is repealed and the following adopted in lieu thereof:

74.05 EQUIPMENT:

- A. Golf carts operated upon City streets shall be equipped with at least the following:
 - 1. A slow moving vehicle sign
 - 2. A bicycle safety flag, the top of which shall be a minimum of five (5) feet from ground level
 - 3. Adequate and functioning brakes
 - 4. Brake lights
 - 5. Rear view mirror
 - 6. Muffler and exhaust system adequate to meet City noise ordinances
- B. UTVs operated upon City streets shall be equipped with at least the following:
 - 1. Adequate and functioning brakes
 - 2. Brake lights
 - 3. Rear view mirror
 - 4. Muffler and exhaust system adequate to meet City noise ordinances

SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.

Q: Describe the project. Provide details of the project and the budget, other fundraising efforts, and the who, what, where, why and how of the project.

A: This January, Driftrunners Snowmobile Club will be hosting its 49th annual Snowfest. As it has been said the past few years, we are working on building up our 50th Snowfest that will be in January 2021. We have began planning for the 50th Snowfest already and looking to have numerous events throughout the 4 days with events driven to both snowmobilers and nonsnowmobilers. With that we are working on saving up monies for the different events and this year we are still doing all our main events just like we have, except changing to a DJ for Saturday night at the expo center, versus having a live band like years in the past. This has also driven down our projected total costs for this year, compared to years in the past. This has also driven us to reduce our requested amount to \$2,750 from our asking of \$3,500 last year. This year we are doing BINGO again as that was a good hit with both snowmobilers and nonsnowmobilers. We still do our 2 rides for charity: fun run for Spina Bifida, and HoCA family ride. We plan to groom the trails the week of Snowfest and that weekend which costs us around \$2,000 just for that time span. The DJ this year will cost us \$500 for Saturday night entertainment. For advertisements we plan to spend around \$3,000. Many of the ads are outside of the Cresco area on radio and magazines. We will have an ad in the Iowa Snowmobiler magazine for January. Like last year, instead of the January issue only going to ISSA members. they will be sending the magazine to all snowmobile owners in the state of Iowa. Other radio ads we have done include to cover the Waterloo, Mason City, and Cedar Rapids areas. We plan to do the same this year with the same radio stations. Some advertisements will continue to remain

with local outlets to ensure Cresco folks know what is going on. As said in the past, if this grant is not awarded, we will still have Snowfest. We would also like to thank you for the support we have received in the past and hope everyone can make it to Snowfest in January. As said earlier, our 50th event is in 2021 and we expect we will be asking for a higher amount requested, and with that plan on having a larger lineup of events and activities that will happen.

Q: How does this project promote Cresco tourism and how does it increase lodging use within the community?

A: The Driftrunners is a non-profit club that was established in 1968 and has a long history of snowmobiling and helping to bring people to Northeast Iowa. Each year we contribute to different charities including Spina Bifida and HoCa in Howard County. This years Snowfest will take place from January 23rd through 26th. Each year we expect 200 people to show up and if we have a nice amount of snow, that number can be closer to 500. Our 2 main events during the winter season are Snowfest and Charlies Chili Feed, while both of these events draw in outside visitors, there are numerous times throughout the winter season on weekends and weekdays visitors with trailers and snowmobiles will be parked at the hotels in town. We work to maintain easy trail access for visitors right next to the hotels and gas stations so they do not have to try and figure out how to get on the trails and potentially trespass onto property. This access we have received positive remarks for and helps show a positive attribute of the Driftrunners and brings people to town. Our club also works with numerous businesses throughout the year to promote their services. We will have club rides that start or end at different businesses in town as well as promote them as being sponsors to our club.
